#### I. Audience to Visitors

No person attending addressed the Board of Directors.

# II. Motion made by Director Davis and seconded by Director Rodman McCray to approve the election of Dr. Vinni M. Hall as a member of Southland's Board of Directors.

Dr. Davis reviewed Dr. Hall's educational background and noted that she has served on the Illinois State Board of Education, is an adjunct professor at Chicago State University and has worked with the University of Illinois at Chicago. Dr. Davis said that it was without reservation that she recommended Dr. Hall as a member of the Southland Board of Directors. Dr. Davis noted that Dr. Hall sat on the State Board of Education which heard Southland's appeal to open as a charter school and she has supported Southland over the years. "Dr. Hall understands what we are about," said Dr. Davis.

Upon the motion duly made, seconded, and carried by a unanimous voice vote of 3 YEAS and 0 NAYS it was:

RESOLVED, Dr. Vinni M. Hall was approved as a member of Southland's Board of Directors.

Member Rodman McCray said the Board was delighted to welcome Dr. Hall. Dr. Hall commented that she attended Southland's Spring concert and she was "blown away" by the performances. "What is being done here manifests itself in the students. I am happy to be here and honored to be named a member of the Board of Directors," said Dr. Hall.

Dr. Davis commended the staff members on what they contribute to Southland. She thanked them for accepting the challenge to educate every child well. # XI. Report from the Chief Executive Officer

At the request of Chief Executive Officer Dr. Blondean Y. Davis, Mr. Ron Anderson, college counselor, reviewed for the Board some important facts about the Southland Class of 2015. Mr. Anderson reported that \$13,276,000 in institutional scholarships had been awarded to the Southland Class of 2015, with six students each receiving between \$500,000 and \$1 million in scholarships, and two students each receiving more than \$1 million in scholarships. Mr. Anderson said that every student received at least \$5,500 of merit scholarships. Mr. Anderson said that Southland was able to save students and their families \$72,000 in application fees, ACT testing fees, SAT testing fees, and enrollment deposits. Mr. Anderson noted that the scholarships earned by the Class of 2015 met and exceeded the excellent results achieved by Southland's inaugural Class of 2014. He said that 64 percent of the students in the Class of 2015 has committed to the student's first college choice. Mr. Anderson thanked the Southland faculty for helping the students with their essays, as well as their assistance in providing letters of recommendation for their students.

Director Hall thanked Mr. Anderson for the wonderful information provided. "Kudos to you and your staff," she said to Mr. Anderson. Director Rodman McCray said she was impressed last year, but this year the accomplishments are over the horizon.

Dr. Davis and Andrea Kidd reviewed graduation preparation and the activities that would occur prior to graduation day. It was noted that astronaut Mae Jemison would be the graduation keynote speaker. Dr. Davis said that outside sponsors had provided \$100,000 in support for the graduation activities.

Finally, Dr. Davis advised the Board that the Southland parking lot would be repaved the week of June 1, 2015.

XII. Director Murphy moved, seconded by Director Rodman McCray, to adjourn the meeting. The motion passed unanimously on a voice vote and the meeting adjourned at 6:40 p.m.
