RESOLVED, the at-will employment of Ms. Sherry Grutzius as Southland's Director of Instructional Support for English, Global Language and Humanities during the 2017-2018 school year, pursuant to the terms of an employment agreement to be entered on behalf of the Parties was approved.

Dr. Davis stated that she was aware when she met Ms. Grutzius that Ms. Grutzius believed in the school's mission and Ms. Grutzius has proven her dedication to this mission since then. Dr. Davis noted that she is enthusiastic about Ms. Grutzius moving into her new administrative position and that Ms. Grutzius has Dr. Davis' full support and confidence.

Ms. Grutzius read a statement in which she thanked the Board and Dr. Davis for this opportunity. Ms. Grutzius related that she did not start out in the classroom, but was a lawyer with the goal of saving the world. However, instead she was in a cubicle writing briefs and was not happy. As she explored other options, she applied for a teaching position, was accepted, and never looked back. She has been a teacher for 22 years, the last four at Southland. Ms. Grutzius said she tells her students, "I left law for you, and I couldn't be happier."
